SUMMARY DESCRIPTION:

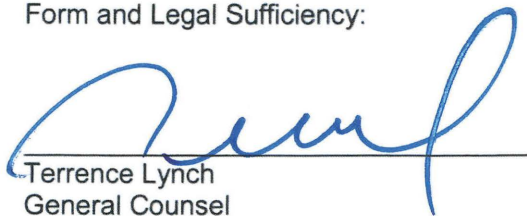
The Broward Sheriff's Office submits this LETF request for the purchase of an Airport Active Response Vehicle. This funding will support the acquisition of an armored vehicle specifically designed to respond to active threats within the parking garages at Fort Lauderdale-Hollywood International Airport, which have height restrictions. The current 7'3" clearance prevents the SWAT Bearcat from being deployed in these areas. The proposed vehicle will be stationed at Fort Lauderdale-Hollywood International Airport and operated by trained personnel assigned to the airport.

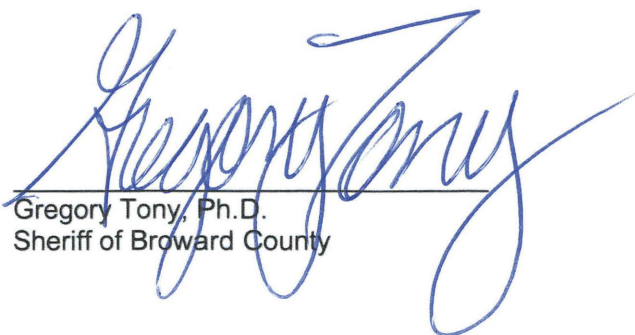
